President's Report: President Mike called Hillsborough County to look into our streets/sidewalk fix. The

County put in another ticket, one for streets and separate ticket for sidewalks.

Mike also spoke to neighbors about self Help Program but progress has not been made. Tentatively decided we won't do our own sidewalk repairs or root cutting so there is no

liability on our part

## **New Business:**
