Meeting was called to order at 6:35 pm by President Mike Arduini in physical attendance

Approval of Minutes: Minutes of 9 April 2025 meeting were approved and uploaded to Timber Pond III website

Treasurer's report: Balance end of April 2025 = \$28,962

1 home left to pay annual dues

Carol filed online form to get assessment (\$115) from owner who has not paid -house is

going to foreclosure; \$25 filing fee paid by Carol

Insurance lapse due to miscommunication, Carol is getting it reinstated, may have to get a

new policy

Carol is providing Steve a list of all HOA expenses to be included in the next newsletter

Daphne house sold, will get new owners a welcome packet

June 1st a late fee will be applied raising dues to \$150 - not applicable for final payment due

to foreclosure

President's Report: Revisit discussion of posting board meeting notifications. For now, posting will be on the

Noise complaint at Daphne due to workers working past 8pm with heavy machinery. Steve addressed it in person. Andrew and Steve also addressed workers in person following

5/14/25 board meeting.

Due to owner complaints that the neighborhood is going downhill and potentially lowering home values, should we start implementing by laws: trash can rule that they can not be left

out in sight, maintaining grass/no parking on grass, etc.

New Business: Can we have chickens-bylaws say no, Hillsborough County allows buy bylaws are

applicable if more stringent

Old Business: State law that HOA meetings are posted so members have a right to attend and speak
